The workshop was called to order by Chairman Rivers at 2:45 pm.

Chairman Rivers recognized Ben Stoner to present a draft of the FY 2014 budget. There was an in depth discussion for the upcoming fiscal year's budget. Discussion was made to hold the Public Hearing to present the FY 2014 budget on June 18, 2013 immediately following the Regular Monthly Meeting.

Secretary Rea moved to hold a Public Hearing on June 18, 2013 immediately following our Regular Monthly Meeting at 4:30 pm to discuss the FY 2014 proposed budget. The proposed percentage increase in the budget from FY 2013 to FY 2014 for the Fire Department is 3.0% and for the Sewer Department is 2.1%. The FY 2013 tax millage rate for the Fire Department is 50.4 mils and the proposed tax millage rate for FY 2014 is 51.9 mils. The FY 2013 tax millage rate for the Sewer Department is 19.0 mils and the proposed tax millage rate for FY 2014 is 19.4 mils. Seconded by Vice Chairman/Treasurer Wavle, the motion carried unanimously.

Vice Chairman/Treasurer Wavle asked Mr. Stoner to complete the Public Hearing Notice that is to be published with the updated information. The Notice of Public Hearing will be published in the Sunday June 2, 2013 edition of The Greenville News and the Wednesday June 5, 2013 edition of The Greer Citizen.

There being no further business, Secretary Rea made a motion to adjourn the meeting. Seconded by Vice Chairman/Treasurer Wavle, the motion carried unanimously and the meeting was adjourned at 4:05 pm.
